IRS Guidelines and Information Donating to Goodwill Stores

January 12th, 2019 - According to the Internal Revenue Service IRS a taxpayer can deduct the fair market value of clothing household goods used furniture shoes books and so forth Fair market value is the price a willing buyer would pay for them Value usually depends on the condition of the item By law a charity cannot tell you what your donated items are worth
